To ensure the enjoyment and safety of your children, we require that all of the following company policies be adhered to. Responsible parent must sign on behalf of all students using this service before the vehicle departs the initial pick-up location. This is a contractual agreement between Stirling Coach Transportation, LLC and "Client" named above. "Guest(s)" designates all students using this service under this reservation.

1. All vehicles owned and/or operated by Stirling Coach are designated **non-smoking**.
2. Alcoholic beverages and illegal substances are prohibited within 100 feet of any Stirling Coach vehicle. Stirling Coach and its' chauffeurs will not allow the consumption of any alcoholic beverage(s) or illegal substances(s) by any "Guest". Stirling Coach reserves the right to immediately terminate the service, for all "Guests" in attendance for the use of alcohol and/or illegal activity by any "Guest" in attendance. The responsibility of Stirling Coach will be limited to contacting the "Client" (responsible parent), whose name appears below, and must be available for the duration of the service, at the telephone number(s) noted, and request that someone come and pick-up all "Guests"; at the local authorities. All monies will be forfeited, due to the negligent behavior of the "Guest(s)".
3. All bags must be stored in the trunk of the hired vehicle for the duration of the service. The chauffeur reserves the right to ask any "Guest(s)" to open his/her bag for inspection. If the request is denied, the bag may not be allowed into the trunk of the hired vehicle.
4. Any authorized stop(s), and the final destination address will be noted at the bottom of this contract by the "Client". Unauthorized stops will not be allowed.
5. All vehicles are thoroughly cleaned and checked for damage prior to each engagement. The "Client" shall be responsible for any cleaning or repairs which may be required, including loss of use charges, due to any act of negligence or disregard by any "Guests(s)". Please note: Vomiting cleaning fee is an additional \$250-\$350 and results in immediate termination of services and forfeiture of all monies.
6. All hired vehicles will remain at the designated prom facility until all "Guests" are ready to leave.
7. The divider will remain open throughout the entire services.
8. Stirling Coach will hold items left behind for 30 days. Please inspect the vehicle prior to final drop-off.
9. The "Client" authorizes any overtime charges, or additional expenses incurred during the course of service, to be charged to the credit card on file.
